#### **Protected Areas**

Creating new protected areas, supporting the effective operation of those already existing.



#### **Environmental Impact Assessment**

Monitoring projects and providing comments to eliminate damage to biodiversity.

#### **Emerald Network**

Creating and monitoring Emerald Network territories and working with international nature conservation conventions.

### **#**

#### Wetlands

Preserving rivers from new dams and other harmful infrastructure projects, protecting wetlands from drainage, reducing anthropogenic impact on grasslands, swamps, watercourses, and water bodies.



#### **Forest conservation**

Protection of valuable forest ecosystems and biodiversity, promoting the principles of sustainable forest management, civic oversight over the legality and sustainability in forest management.



#### **Biodiversity Research**

Collecting, assessing, and analyzing information on rare species and valuable natural habitats for conservation purposes; popularizing biodiversity topics and modern research methods among scientists and the general public

**We work towards improving legislation.** In recent years, with our participation, a law introducing the conservation of naturally afforested agricultural lands, steppes, and grasslands was adopted; Cabinet of Ministers resolutions were passed on creating protective zones for biodiversity preservation and new rules for forest management planning.

## The importance of peatlands and wetlands:

- biodiversity conservation;
- climate regulation (carbon storage);
- water purification and regulation of the hydrological cycle;
- and many other things...

However, this areas are rapidly disappearing due to agricultural development. This is because their conservation is not sufficiently regulated.

On the contrary, there is an incentive to plow land to support the economy and food security of the country.

In Ukraine, arable land accounts for <u>56.8%</u> of the country (World Bank data).



## Incentives to increase arable land:

- "Ukraine is the breadbasket of Europe";
- stimulate the expansion of arable land;
- low state control over land use;
- subsidies for land reclamation (drainage, irrigation);
- the Government plans to provide subsidies for the use of degraded, unproductive and contaminated land;
- lack of understanding that ecosystem services have a value.



# **Directions of agricultural policy**

Vitaliy Koval, <u>Minister of Agrarian Policy</u>, notes that the priorities for 2025 include European integration, demining of agricultural land and returning it to cultivation, digitalization, development of agro-processing, support for small and medium-sized farmers, especially in the frontline areas, development of livestock, fisheries and **Melioration**.

# <u>There is no specific legislation on the</u> protection and use of peatlands in <u>Ukraine</u>

The **Land Code** of Ukraine.

Article 150.

1. Particularly valuable lands include:

•••

b) peatlands with a peat depth of more than one meter and drained regardless of the depth, peatlands within wetlands of international importance.

•••

3. The peculiarities of the legal regime of land use under peatlands and possible types of their designated purpose are determined by the Cabinet of Ministers of Ukraine.

# Does Ukrainian law protect wetlands?

For water bodies, the law establishes coastal protection strips, which are protected areas that cannot be plowed. Their width is regulated - from 25 meters to 200 meters. But, as I said earlier, Ukraine has low state control over land use, so such buffer zones are often plowed up.

### Solutions for peatland and wetlands conservation:

- strengthen control and responsibility for the use of land within the wetlands and peatlands.
- provide support to farmers who do not violate environmental legislation.
- develop a Regulation on peatlands;
- create protected areas and zones;

- to unite with foreign partners to preserve the world's wildlife and prevent climate change...
